## STEWARDSHIP - OUR PROMISE

It doesn't matter how a parcel of land comes to the Cheshire Land Trust. The bottom line is that once given, we then have an obligation. It's a promise to conserve and steward the land that is in our care.

This is where monitors and stewards come into play. Each one is a volunteer and each one is extremely valuable to land trusts.

Monitors: Assigned to a specific parcel of land, a monitor acts as the eyes and ears of the land trust.

They walk the property at least once a year, checking on boundary markers (have they moved, are they missing, etc.).

They also walk the property making notes along the way on items of concern, such as illegal dumping, a fallen tree on a trail or erosion problems. The monitor writes a report, and sends it to the land trust board.

**Stewards:** These volunteers may also double as a monitor of a property, but stewards are essentially the" go-to people" to make things right when something needs doing at the property.

## A Steward's Bag of Tricks

The skills stewards carry with them vary from person to person and property to property.

Stewards may work alone, or work in groups as small as two or as large as a dozen for a scheduled workday or a big project.

All skills are welcome. Here are just a few items stewards might volunteer to handle:

- Cut back invasive shrubs
- Blaze tralls
- Remove fallen branches
- Flx benches
- Pick up trash
- Mow and trim
- Cut and clear downed trees
- Build trails / bridges
- Paint
- Plant trees
- Put up new trail signs


### Fun and Adventure

## A Calendar Year with CLT

As I write this, it is a rainy and raw day in the midst of Winter. The sky is gray, the breeze has a bite to it, and yet, the air is rich with the promise and smell of Spring.

I am sitting here looking at my photographs from the past year with CLT.

I recall several hikes, in different seasons. A year ago, I was out hiking at Ives Farm. We walked down to the river and looked at the tracks in the snow. There were deer tracks, maybe coyote, and a few we could not identify. The sky was a rich beautiful blue. The air was crisp and clean.

In April, we took a wildflower hike at Roaring Brook with CLT member Sigrun Gadwa. The variety of wildflowers found was delightful. Canada Mayflower, Spicebush, Red Trillium, Bloodroot, Trout Lily and more bedazzled us with their delicate charms. The woods, so green and damp, so full of the promise of Spring to come, so very welcome after a snowy winter.

In June, I co-led a hike with the Cheshire Environmental Commission on CT Trails Day. While our two groups are not affiliated, CLT is a private non-profit conservation group, our goals on open space align. We are happy to work with them for the benefit of the residents.

About twenty of us hiked the town-owned Dedominicus open space property looking for migrating birds and wildflowers. The forest was thick with green foliage by then.

A few months later, there was a stroll through Fresh Meadows, where we found Monarch Butterflies and caterpillars.

Later in the season, back at Ives Farm, we had the #Opt-Out, Black Friday Hike. We crunched through the lower field, finding turkey and coyote tracks, discussing invasive plants with help from master gardener Walter Brockett (Peter's Rock Association) and having a friendly hike among friends.

And, CLT hosted other events, too. On July 9<sup>th</sup>, we had a very different event. About a dozen artists of varying genres took to the stage, making wonderful music at lves Farm. What a nice afternoon it was, with so many people enjoying the weather, the music and the beautiful expanse of field and sky.

In September, we held our annual "Day at Ives Farm" with more than 1,000 visitors. There was face painting, pony rides and farm animals, letter boxing, food and music. Our second annual Ives Farm Tractor Trot 5K Walk & Run was in October, and turned out to be a great success and a lot of fun.



I also remember the stewardship work parties behind the trail walks and big events. When and where possible, several of us would meet, unpack tools from our cars and head out into the woods and fields.

We'd spend a few hours making the trails passable, and improving the environment by cutting down invasive plants. Sometimes it was sunny and warm, sometimes it was cold, but the work still needed to be done.

Did we consider it work? No, actually, I think we considered it fun or exercise, or service, but certainly not drudgery. Why? Because we were outside with our friends, working and enjoying the spring, summer or fall, and above all, enjoying the land.

Last year was a wonderful year, and this year should be even better. We would be honored if you would join us on the journey.
